Sir,

I am directed to convey the sanction of the President of India for payment of ₹27143.49 crore (₹ Twenty Seven Thousand One Hundred Forty Three crore and Forty Nine lakh only) as indicated in column 10 of the enclosed statement being the payment of States' share of net proceeds of all shareable Union Taxes and Duties on Thirteenth Finance Commission's recommendations payable to the State Governments due in December, 2014.
