

#### **Health Sector**

### AB-PMJAY "SEHAT" Scheme

• AB-PMJAY "SEHAT" Health Insurance Scheme in convergence with AB-PMJAY was launched by Hon'ble Prime Minister for health coverage for free medical treatment upto Rs 5 lakh per family to all 21 lakh families of UT of J&K.

# Oxygen Generation Plants/Machinery & Equipment

- Establishment of 37 Oxygen Generation Plants in all Medical Colleges, Associated Hospitals and District Hospitals of UT of J&K to cope up with additional requirement of medical oxygen due to COVID-19 pandemic at a cost of Rs 227.73 crore.
- Machinery & Equipments worth Rs 367.49 crore are being procured for health institutions through World Bank aided project.

#### Tertiary Care Infrastructure

- Establishment of two medi-cities.
- Operationalization of 500 bedded paediatric hospital at a cost of Rs. 116.25 crore at Bemina, Srinagar.
- Construction of 200 Bedded Additional Block at Lal Ded Hospital Srinagar at a cost of Rs. 132.50 crore.
- Construction of 120 Bedded Specialized Orthopaedic Unit with 6 Bedded ICU at Bone and Joint Hospital Srinagar at a cost of Rs. 88.94 crore.

#### Medical Educational Infrastructure

- Two New Medical Colleges at Udhampur and Handwara (District Kupwara) have been approved at a cost of Rs 325 crore each.
- Establishment of Cancer Institute at Srinagar & Jammu at a cost of Rs 120 crore each.
- Establishment of "Institute of High Altitude Medicinal Plants" in J&K at Bhaderwah with an estimated cost of Rs 100 Crore.

#### Paramedical/ Other Infrastructure

- 5 Nursing Colleges at Anantnag, Baramulla, Sopore, Gangyal (Jammu) and Kishtwar are being established.
- Up-gradation of existing 10 GNM Schools to the level of Nursing College has been approved at an estimated cost of Rs. 6 crore per college.
- Setting up of Modern Drug Testing Laboratory at Kathua at a cost of Rs. 34 crore.

## Agriculture and Horticulture

# Agriculture Production/ Mechanization

- 7.50 lakh farmers to be benefitted by distribution of one lakh quintal seeds with an investment of Rs 15.50 crore in 2021-22.
- 25000 farmers to be benefitted by covering 87750 Hectare by providing infrastructure facilities like 2500 pump sets, 750 bore wells and construction of many field channels with a provision of Rs 91.27 crore during 2021-22.
- 30000 farmers to be benefitted by providing farm machinery with a provision of Rs 65.81 crore in 2021-22.
- 25000 farmers to be benefitted by establishment of two mandis with a provision of Rs 1 crore during 2021-22.
- 35000 farmers to be trained for capacity building with a provision of Rs 26 crore during 2021-22.
- To strengthen the farmers to meet the accreditation requirement of the Agriculture Universities through indicators like Germplasm production, an amount of Rs. 2.50 crore has been proposed.
- The production of Saffron crop expected to further increase with assured irrigation facility.

#### Sericulture

• For development and production/distribution of quality silkworm seeds along with the infrastructure support, Rs. 7.25 Crores are provisioned.

#### Horticulture

- Expansion of area under High Density Plantation with a target of 120 Hectare in 2021-22.
- Export target for dry & fresh fruit for 2021-22 is 22.30 LMT (22 LMT for fresh fruit & 0.30 LMT for dry fruit).
- Efforts to be taken to double the income of farmers by 2022.
- In 2021-22, Rs. 74.55 crore is provisioned as additional subsidy/support for establishing Controlled Atmosphere Stores with a target to achieve 4 LMT capacity of CA storage in next three years.

## Animal & Sheep Husbandry/Fisheries

#### **Sheep Production**

- Introduction of artificial insemination in small ruminant sector.

- Implementation of Integrated Dairy Development scheme involving induction of 20000 animals in milk pool besides generation of employment.
- Operationalization of Mobile Veterinary Clinics to ensure doorstep delivery of veterinary health care/breeding services to progressive livestock farmers.

#### **Poultry Production**

 Increase in poultry meat production from current 7.8 crore Kgs to 8.5 crore Kgs through implementation of J&K Poultry Policy 2020
 Poultry Development Programme & generation of employment opportunities for 30,000 people.

### Fisheries Production

- Enhancing the current fish production of 21 thousand MT by further 1000 MT through implementation of various schemes.
- Marketing platform to be strengthened with a provision of export of trout to other states of the country.
- New interventions like Re-circulatory Aquaculture systems & Biofloc technologies to be introduced to boost fish production in the UT.
- New hatcheries to be established & existing ones strengthened with multiple tier systems to increase the seed production for the UT & for export as well.

#### **Power Sector**

#### Power Generation

- Decks have been cleared for taking up new hydroelectric power projects like Kirthai-II (930MW), Sawalakote (1856 MW), Uri-I stage-II (240 MW) and Dulhasti stage-II (258MW).
- Modalities have been finalized for 850 MW new joint venture Ratle power project.

#### System Improvements

- 2 Lakh smart meters being installed under PMDP targeted to be completed by June 2021 for all urban consumers.
- Installation of Transformer Cut outs to be extended to all feeders during 2021-22.
- 24X7 e-customer care / call-center for grievance redressal to be established.

## Power Infrastructure

- 22 projects to be completed by October, 2022 for increasing transformation capacity at Grid level.
- Solar plants to be set up across the UT to promote use of renewable energy for which land identified in Pampore, Kalakote & Kawa for establishment of solar plants.
- Optical Grounded Wire (OPGW) project for setting up efficient and reliable communication under implementation by PGCIL under PMRP scheme shall be accomplished to establish reliable/ efficient communication between 220 kV and 132 kV Grid Stations.

### Tourism & Culture

Promotion of tourism by vibrant campaigning and holding of national and international events. New Tourism Destinations to be explored through Public and Private Investment. Water based tourism activities to be encouraged for promotion of adventure tourism. Golf Tourism to be promoted at higher scale by holding national and international events. World class wayside amenities and facilities to be provided besides tourism related assets to be renovated and upgraded to increase and attract the high-end tourists. Focus to be given on preservation and conservation of heritage sites. Showcasing of rich cultural heritage. Local film/cinema/theatre besides festival activities to be promoted.

#### Jal Shakti

100% Piped Water Connections to each and every Rural Household of the UT of J&K by September, 2022 under Jal Jeevan Mission (JJM).

3.83 lakh water connections to be provided during 201-22 covering 19.65 lakh population.

All the uncovered Schools and Anganwadis of the UT of J&K to be provided water connections.

410 Water Supply Schemes are being completed during the financial year 2021-22.

57 Ongoing Minor Irrigation Schemes under AIBP-PMKSY to be physically completed during 2021-22 and the Irrigation Potential of more than 0.19 lakh hectare to be achieved.

"Comprehensive Flood Management Plan of river Jhelum & its tributaries" is expected to get accelerated for achieving the target of enhancing the discharge capacity of river Jhelum to 60,000 cusecs from 41,000 cusecs at Sangam reference point and from 8700 cusecs to 17,000 cusecs at off-take of Padshahi Bagh, Srinagar.

Work on Tawi Barrage (balance portion) and Ujh Multi-Purpose Project (UMPP) to be started.

#### Housing & Urban Sector

#### **Atal Mission for Rejuvenation and Urban Transformation (AMRUT)**

Under AMRUT, 7 projects to be completed in the next financial year which include Panjtirthi Multi Level Parking, Sewerage Treatment of 05 Nallahs of Tawi River at Jammu, Cycle track at Srinagar, Drainage at Trikuta Nagar, Multi Level Parking at Srinagar, ITMS (Intelligent Traffic Management System) phase-II, Srinagar & Water Supply scheme, Rangil.

#### **Smart City Mission**

Under Smart city mission, 40 Projects of different sectors under smart city/convergence/PPP mode are expected to be completed during the next financial year. The main focus is to improve the quality of life of the people by way of providing WiFi facilities, Smart health centres, upgradation of historical markets, installation of vending machines, smart class rooms, Electric Vehicle charging stations, illumination of river banks, development of cycle tracks/hawkers zone, development of parking and space under flyovers.

#### **Sewerage Treatment**

16 new STPs with 74 MLD capacity to be installed which will cater nearly 2 lakh households.

#### **Energy efficient Street Lights**

100% installation of LED Street Lights in all 78 ULBs.

#### Swach Bharat Mission (U) & Solid Waste Management

- 25 ULBs targeted to achieve the status of ODF+ category.
- 100% source segregation and Door to Door collection of waste.
- Establishment of SWM Plant at Srinagar and Jammu for scientific disposal of about 850 MT of waste per day.
- Establishment of decentralized processing units of waste management in 76 ULBs for scientific disposal of 690 MT of waste.

## Pollution Abatement

- Rs. 200 crore earmarked in 2021-22 for rejuvenation and restoration of 9 identified polluted river stretches by CPCB on the directions of NGT.

• Construction of Bal ashram, Nari Neketan Buildings and Half Way homes are being proposed in 2021-22.

#### Relief & Rehabilitation of Kashmiri Migrants

- Out of 6000 posts created for Kashmiri Migrants under PM Package, 3841 posts stand filled and the remaining being recruited currently.
- Out of 6000 units, 1025 units of transit accommodation already completed. The work on 1488 units of transit accommodation to be undertaken in 2021-22, besides land identified for another 2444 units. The other components of the PM package like housing, employment, waiver on loans, cash assistance and free ration shall continue in 2021-22.

### Gujjar, Bakarwal & ST students

- The dropout rate at the high school level is targeted to be reduced from 17.12 further to 15.00 by March, 2022 in J&K.

- Launch of JKPWD Online Monitoring System(JKPWDOMAS) w.e.f. 1st April, 2021 in which all the activities right from preparation of DPR to Final Bill payment to be done in online mode.
- Establishment of Quality Control Laboratory for every District.
- Engagement of National Level Consultant for development of mechanism of monitoring.
- Roll-out of "3rd Party Inspection" system.

#### Road/Bridge Infrastructure

- Under PMGSY I & II, road length of 4500 kms to be completed during 2021-22 and 150 new habitations are targeted to be given road connectivity.
- J&K to be onboard for PMGSY III for which 1750 km road length to be sanctioned for upgradation in 2021-22.
- Under PMGSY IV, Core Network for connecting habitations having 250+ persons as per census 2011 are targeted to ensure 100% road connectivity in J&K by 2021-22.
- Overall 8000 kms of black-topping of roads to be achieved during 2021-22 under Cities & Towns/PMGSY/CRIF/NABARD.
- 14 bridges are targeted to be completed in 2021-22 benefitting 2.85 lakh population.

# Industry

"New Central Sector Scheme for Industrial Development of Jammu & Kashmir" at a total cost of Rs 28400 crore effective from 01-04-2021 upto 31-03-2037 has been notified. All units eligible under manufacturing and eligible service sector to be granted incentive(s) under this scheme as defined under respective incentives viz., Capital Investment Incentive (CII), Capital Interest Subvention (CIS), Goods & Services Tax Linked Incentive (GSTLI) and Working Capital Interest Subvention (WCIS).

This will encourage new investment and expansion of existing industries and generate employment for 4.50 lakh people.

#### **Industrial Infrastructure**

- Rs 200 crore provisioned for Development of New Industrial Estates in UT under Capex Budget 2021-22.
- Construction of Trade Centres with outlay of Rs 50 crore.
