1. Qualification:

- 1.1 Essential: Master's degree or LLB/ LLM with minimum three years post-qualification relevant professional/ academic/ research experience.
- 1.2 Desired qualification for CD Division :- Preference shall be given to a candidate having domain knowledge in the field of Finance or Economics (specially commodity derivatives market)
- 1.3 Desired qualification for Budget Division :- Preference shall be given to candidate with degree in Law/Economics/Finance
- 1.4 Desired qualification for O/o PEA:- Preference shall be given to candidate having a post graduate in Economics with atleast 3 years of experience in macroeconomic apolicy including trade, fiscal marketing, banking
- 1.5 Desired qualification for MI Division :- Preference shall be given to candidate with Masters in Economics from reputed Institution/ University.
- 1.6 Desired qualification for C&C Division :- Experience in Digital Payment area, PSS act and Crypto currency.

2. Age Limit:

Not exceeding 50 years

3. Tenure:

- 3.1 The initial appointment shall be for a period of one year which can be extended to a maximum period of 3 years (1 year + 1 year + 1 year) subject to performance of the professional in the Division concerned being highly useful.
- 3.2 The appointment of Consultant is of a temporary nature and the appointment can be cancelled at any time by the Department without assigning any reason.

4. Other Entitlements/ Conditions

4.1 Remuneration

All inclusive remuneration shall be Rs. 80,000/- per month. The Consultant will be entitled to an annual increment of Rs. 6,000/- in their remuneration, in case the tenure is extended.

4.2 Tax Deduction at Source:

4.3 Other Allowances:

5. Leave :-

Consultant shall be eligible for 8 days' leave in a calendar year on pro-rata basis. Therefore, a Consultant shall not draw any remuneration in case of his/her absence beyond 8 days in a year (calculated on a pro-rata basis). Also un-availed leave in a calendar year cannot be carried forward to next calendar year.

6. Confidentiality

- **A.** The Consultant may not, except with the previous sanction of Department of Economic Affairs in the bonafide discharge of his/her duties, publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or write a letter to any newspaper or periodical, either in his/her own name or anonymously or pseudonymously in the name of any other person, without the prior approval of the DEA.
- **B.** During the period of assignment with Department of Economic Affairs, the Consultant would be subject to the provisions of the Indian Official Secrets Act, 1923 and shall not divulge any information gathered by him/her during the period of his/her assignment to anyone who is not authorized to know/ have the same.
- C. The Consultant appointed by the Department shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the Department.

7. Termination of Agreement

The Department may terminate a contract to which these Terms apply if:

- 1. The Consultant is unable to address the assigned works.
- II. Quality of the assigned works is not to the satisfaction of the Department.
- III. The Consultant fails in timely achievement of the milestones as finally decided by the user division.
- IV. The Consultant is found lacking in honesty or integrity or violates the confidentiality clause.
