Minutes of the meeting of the Committee on Compassionate Appointment held on 8th November, 2023 under the Chairman of Director (Admin) for selection of two candidates for the post of Multi-Tasking Staff on compassionate grounds.

The meeting of the Committee constituted for Compassionate Appointment for evaluating and assessing the suitability for selection of candidates for compassionate appointment in the Department of Economic Affairs was held on 8th November, 2023 at 11:30 AM in the Chamber of Chairman viz. Director (Admin) to fill up the 02 posts of MTSes on compassionate ground for which an advertisement was floated by this Department on 29th September, 2022.

- 2. At the outset, the Committee was briefed about the calculation of two vacancies for compassionate appointment in terms of DoP&T guidelines wherein 5% of the vacancies arising in a particular year are to be set aside for compassionate appointment purposes. This Department has maintained a ratio of 19:1 of vacancies to be filled through Staff Selection Commission (SSC) and on Compassionate Appointment in order to stay the 5% quota relevant. In terms of ratio reserved, a total of 2 vacancies were earmarked for this instant compassionate appointment drive launched in the department.
- 3. Upon advertisement, this Department has received 42 applications from the members of family of deceased employees. Out of these 42 applications, 02 were found to belong to Department of Expenditure [Lt. Shri Nathuram & Lt. Shri Harlal]. The said applications were forwarded to Department of Expenditure with the request to consider their candidature as when appointment on compassionate grounds is made by them in their department. Out of the remaining 40 applications, 38 (Thirty Eight) were of those wherein the deceased employees had held the regular Government post and 02 (two) were from the dependents of deceased employees who had been the employees of Security Printing & Minting Corporation of India Limited (SPMCIL) and Government Optee, at the time of the formation of the Corporation.

- 4. The Committee evaluated the said application on a 100 points-scale marking system, devised by the Department in terms of Department of Personnel and Training (DoPT) guidelines, taking into consideration the economic condition of family of the deceased including the applicant, viz; death/ pensionary benefits, income, property, dependent members, unmarried daughters, minor children, loan etc., which shall aid in the process of objective evaluation of candidates.
- 5. On scrutiny, the Committee found the application of Smt. Upal Pareya W/o Late Shri Baij Nath Pareya was not considered since "Affidavit" was not provided by Applicant, a mandatory document for consideration of appointment on compassionate basis. Though the Office has reminded the candidate time and again to produce the same.
- 6. Onwards, the Committee during the evaluation process pointed out that Annual Income, which is one of the parameters in the 100-point based merit system, should contain the earning of all dependents at the time of the death of the Government Servant, including married dependents (son/daughter) at the present. The Committee also had some other observations with respect to some of the applications. Per the directions of the Committee, clarifications were obtained from the concerned applicants and the Committee re-assembled on 6th December, 2023 to finalize the selection.
- 7. Subsequently, the Committee upon evaluation and assessing the applications awarded marks to the applicants on each of the parameters and taking into account the number of vacancies for compassionate appointment i.e., 02 (Two), the Committee decided that twice the number of vacancies may be considered for compassionate appointment. Accordingly, first four candidates in order of ranking in the Summary Sheet as indicted below were considered:

 - ii. Ms. Mamta Devi W/o Late Sushil Kumar (Ex- MTS)
- (b) The offer of appointment will be subject to the condition that if anything is found incorrect/misleading in the application form of the applicants, his/her candidature(s) would be withdrawn with immediate effect, along with submission of the required undertakings by the candidates.
- (c) Necessary action to be taken to place the records on the website of this Department in the light of the DoPTs OM No. 43019/9/2019-Estt(D) dated 23rd August, 2021.
