- **5. Other Allowances**: No other facilities such as phone/conveyance/transport, travel, personal staff, medical reimbursement etc. would be admissible.
- **6. Attendance & Working days:** The working hours of the consultants shall be same as regular Government employees working in DEA. No extra remuneration shall be allowed for working beyond office hours or on Saturdays/ Sundays/ Gazetted holidays. Compensatory leave in such cases shall be at the discretion of the JS/Adviser of the concerned division. The attendance in and out shall be marked in the Biometric system.
- **7. Leave**: The individual consultants shall be entitled to leave at the rate of 1.5 days of each completed month with no accumulation of leave beyond a calendar year on pro-rata basis. Apart from this the women Consultant may be eligible for maternity leave as per the Maternity Benefit (Amendment) Act, 2017 issued by Ministry of Labour and Employment vide no S-36012/03/2015-SS-1 dated 12<sup>th</sup> April, 2017.
- **8.** Tax Deduction at Source: The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Department of Economic Affairs will issue TDS Certificate to the Individual Consultants. The Department of Economic Affairs undertake no liability for taxes or other contribution payable by the Individual Consultant on payments made under this contract.

- **9. Police Verification:** Police verification of the Individual Consultants shall be done as per the latest instructions issued by MHA. In case the police verification is received as negative, the contract of individual consultant shall cease to exist with immediate effect without any notice.
- **10. Service Condition:** The High Level Consultants shall not, except with the previous sanction of Department of Economic Affairs, in the *bona fide* discharge of his duties, publish a book or a compilation of articles or participate in a radio broadcast or representing any private entity in legal or commercial matters or contribute an article or write a letter to any newspaper or periodical, either in his own name or anonymously or pseudonymous in the name of any other person, if such book, article, broadcast, uses any information that he may gather as part of this assignment.
- 11. Confidentiality and Secrecy: During the period of assignment with Department of Economic Affairs, the High Level Consultants would be subject to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by him during the period of his assignment to anyone who is not authorized to know the same. Selected candidates shall provide integrity certificates from 2 references known to them. A self-undertaking shall be provided by the candidate to the effect that he/she has no criminal record or criminal case in any court is pending against them.
- 12. Period, Termination of Services and requirement of notice: Period of engagement shall be till March, 2024. In case a consultant wishes to resign from his/her position, he/she shall furnish at least one month's notice period or salary in lieu thereof. Secretary (EA) may waive off the condition for notice period/salary in lieu thereof, in deserving cases. DEA shall have powers to terminate any or all the High Level Consultants at any time without assigning any reason, with the approval of the Secretary (EA). Absence from duty for a continuous period of 12 days, without any information or any valid reason shall lead to automatic termination of contractual engagement.
