- 1) Application are invited from eligible persons for appointment to the post of Regional Director(Jr) in Pay Matrix - 10 in PB-3 (Rs. 15600-39100) + Grade Pay Rs. 5400 on deputation basis from Officers of the Central/State Government/Union Territories having the qualifications and experience as mentioned in Annexure - I
- 2) The application of the eligible and willing Officers and who can be spared immediately may be forwarded through proper channel in the prescribed proforma (Annexure-II) alongwith attested copies of ACR/APAR(attested on each page) for the last five years, Cadre Clearance Certificate, Vigilance Clearance Certificate, Integrity Certificate and details of Major/Minor Penalty imposed during last ten years in the enclosed proforma(Annexure-III). The applications may be forwarded to the undersigned within a period of 60 days from the date of issue of the Circular/ Advertisement.
- 3) While forwarding the applications it may be verified and certified that the particulars furnished by the Officers are correct. Applications received after the last date or without character rolls or otherwise found incomplete will not be considered. No action will be taken on advance copies or applications not received through proper channel.
- 4) The candidates who apply for the post, after appointment to the post of Regional Director(Jr) will not be allowed to withdraw their candidature unless they complete the deputation period.

ELIGIBILITY CONDITIONS FOR APPOINTMENT TO THE POST OF REGIONAL DIRECTOR(Jr) BY TRANSFER ON DEPUTATION BASIS.

- 1) Name of the post : Regional Director(Jr), (Group 'A', Gazetted)
- 2) No. of posts : 4
- 3) Place of posting : Anywhere in India (i.e. New Delhi, Mumbai, Chennai, Kolkata, Guwahati)
- 4) Scale of pay : Pay Matrix - 10 in PB-3 (Rs. 15600-39100 + Grade Pay Rs. 5400)
- 5) Method of Recruitment : On deputation basis
- 6) Eligibility :

Officers under the Central/State Governments/Union Territories:

- (a)(i) Holding analogous post on regular basis in the parent cadre/department; or
 - (ii) with 2 years service in the grade rendered after appointment thereto on a regular basis in posts in PB-2 (Rs. 9300-34800) with Grade Pay Rs. 4800 or equivalent in the parent cadre/ department; or
 - (iii) with 3 years service in the grade rendered after appointment thereto on a regular basis in posts in PB-2 (Rs. 9300-34800) with Grade Pay Rs. 4600 or equivalent in the parent cadre/department; and
 - (iv) having experience in Banking and/or Insurance, Market research and Training; and
- (b) Possessing the educational qualifications and experience as under:

ESSENTIAL:

- (i) Master's degree of a recognized University or equivalent i.e. M.A., M.Sc., M.Com & MBA. And
- (ii) 3 years Experience in Banking and/or Insurance/Academic Institution/ Market Research and Training including experience in Public Relations, Publicity work or experience in supervisory capacity in a commercial, Govt. or Semi-Govt. Organisation.

DESIRABLE:

- (i) Knowledge of two regional languages.)

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years, as on the closing date of receipt of applications.

Note : For the purpose of appointment on deputation/absorption basis, the service rendered on regular basis by an officer prior to 1.1.2006 (the date from which the revised pay structure based on the 6th CPC recommendation has been extended) shall be deemed to be service rendered in the corresponding Grade Pay/Pay Scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay/Pay Scale, and where this benefit will extend only for the post(s) for which that Grade Pay/Pay Scale is the normal replacement grade without any upgradation.
