The Guarantee already approved by Budget Division but not executed till 31st March 2017 also needs to be revalidated through Budget Division. Therefore, such amount may also be included in the total guarantee requirement for FY 2017-18. The information sought is only to have an overall picture of Guarantee requirement for 2017-18 and to allocate guarantee space. Mere projection of the Guarantee requirement and allocation of space should not be construed as Guarantee has been approved by the Competent Authority.
- 3. The requirement of guarantee for the Financial Year 2017-18 may be furnished as per format attached at Annexure-I. Ministries/ Deptts are also requested to provide details of past guarantees as per format at Annexure-II. Both the format must be filled meticulously and sent to Budget Division within the prescribed time. <u>NIL' information may also be specifically sent.</u>
- 4. The information may be sent to the undersigned **b** by dak and email latest by 1.5.2017. It is highlighted that beyond 1.5.2017, no request of requirement of guarantee space will be entertained and guarantee space will be allocated on the basis of information received upto 1.5.2017.
- 5. All the Ministries/ Deptts are also requested to furnish information as sought in Annexure-II, even if no guarantee space is proposed during 2017-18, failing which it shall be presumed that no guarantee is currently outstanding and a blanket order cancelling all non-reported cases would be passed based on this presumption.
